The Northeast Florida Freight Movement Study is being conducted by the Florida Department of Transportation District Two with the overall goal of enhancing and expanding freight mobility for the 18-county Northeast Florida region. The study's objectives include:

- Develop a regional branding for freight and related services;
- Leverage public-private-partnership opportunities;
- Create a living document that is a useful tool for public and private sector stakeholders;
- Design the document to be upward looking to align with Federal and State policies while being tailored to meet local and regional freight needs;
